AtosCapital24 Markets (Pty) Ltd ("we", "us" or "ATOS Markets"), is a company registered and headquartered in South Africa (registration number: 2020/595755/07), and a financial service provider authorised and regulated by the Financial Sector Conduct Authority ("FSCA") under FSP license number 51268, governed by the Financial Advisory and Intermediary Services Act, 2002 (Act No. 37 of 2002).

2. COMMITMENT

3. Atos Capital 24 MARKETS COLLECT PERSONAL INFORMATION

- to tailor the website or other service we provide to you to your needs and interests; and
- to create anonymized statistical data.

You consent to AtosCapital24 Markets using your personal information for the above-stated purposes. You also consent to atoscapital24 Markets transferring your personal information out of South Africa where this is necessary for AtosCapital24 Markets to fulfill its contractual obligations to you. Please note that AtosCapital24 Markets only transfers personal information to organizations out of South Africa if AtosCapital24 Markets has assessed the organization as having appropriate controls and safeguards in place to protect your personal data.

6. WHO MAY AtosCapital24 MARKETS DISCLOSE THIS INFORMATION TO?

- any authority to whom AtosCapital24 Markets is required to disclose such information by law. Please note that AtosCapital24 Markets does not sell or provide your personal information to third parties for marketing purposes.

7. UPDATING YOUR INFORMATION
